FDA STATUS

Cola®Wet MA-80 surfactant is permitted under 21 CFR 178.3400 of the Food Additives Regulations for use as an emulsifier and/or surface active agent in the manufacture of any non-food article intended for food-contact use. There are no limitations on the nature or amount of use of Cola®Wet MA-80 surfactant other than the general limitations set forth in Section 174.5 which are applicable to every substance listed in Subpart D.

STORAGE AND HANDLING
